Copper Shade Tree is a fine craft gallery and an educational tool for fine craft in Texas. Therefore, we challenge our artists to search for new levels of creativity, and encourage them to create artwork that has never been seen before.

As we prepare for the Art in Fiber 2011 Show, we would like to invite you to participate in the jury process. This will be the fifth year to host this popular event. The 2010 show was extremely successful, thanks to the diverse collection of quality artwork and unique designs, created by the selected artists.

Once again, the focus will be on Fiber Art for the wall. Our definition of Fiber Wall Art is: art quilting, thread painting, weaving, felting, etc. that are framed (without glass), or applied to painted canvas or fabric covered canvas. Art quilts may be the traditional hanging method with sleeve and stick. A juror will select twenty-four artists to participate in the show. **(Must be a Texas resident in order to apply.)**

The requirement for the 2011 show includes a minimum of four (4) Fiber Art wall pieces:

- One (1) themed fiber art on 11" x 14" x 1-1/2" painted or covered canvas (**your choice of color**) with the theme - **"Interpretation"**. Each selected artist will be given a photo of 3-D artwork, a music arrangement on a CD, **or** a poem. Each artist will be required to create their fiber art based on their "interpretation" of the media selected for them after the jury process. **The canvas will be provided.**
- Minimum of three (3) Fiber Wall Art pieces: Maximum size: 4' wide x 5' long and the minimum size is 8" x 10". (size is limited due to space restrictions, however you are encouraged to submit different sizes to show your diverse creativity).
- Either mail or hand-deliver one (1) finished piece of artwork for the jury process.
- Each piece of artwork will be your original design.
- Each piece of artwork will be created exclusively for "The Art in Fiber 2011".
- **Work cannot have been exhibited in any other show or competition.**
- \$35 application fee (non-refundable).

Copper Shade Tree reserves the right to reject any piece of art at the time of delivery.

| September 1, 2010 | Deadline for submitting your application and one (1) finished piece for the jury process. May be mailed or hand-delivered. |
| September 9, 2010 | Copper Shade Tree will notify the individual artists of the jury results. Once selected, further detailed information will be distributed to the artists. |
| December 1, 2010 | Deadline to deliver the "Interpretation" artwork. A hardcover book is being planned for this series. |
| January 17 – 21, 2011 | The artists, who have been selected for the show, will bring their finished pieces to the Copper Shade Tree for final selection. An appointment will be set with each artist during these dates. |
